Subject: Audit Committee Compliance Commitment

Dear Fellow Board and Executive Council Members:

On the eve of the second phase of our New York trial, I write to share an important document.

It was provided earlier today by Audit Committee Chair Charles Cotton, who put it together as he prepared to testify. It reflects input from the entire Audit Committee (including new members Charlie Beers, Eb Wilkinson, and Rocky Marshall), along with Alex Reid and Bob Mensinger. I reviewed and resoundingly endorse it. It is a statement of our absolute commitment: a transparent NRA committed to good governance.

This is not a formal Board resolution, but an undertaking by the Audit Committee. As Charles and others take the witness stand over the next two weeks, and as gossip and misinformation continue to flow, I believe it is vital to underscore this commitment. If a monitor is off the table – and it should and must be – the NRA could make this pledge to our Board and our members.
